**Council Meeting Minutes**  
**August 13, 2018**  
**7:00 PM**

President, Lance Barthel called the council meeting to order at 7:00pm. The Pledge of Allegiance was recited and innovation given by Mayor Troutman.

**Consent Items**

A motion was made by Steve Copp, seconded by Charles Wentzel and approved with one nay vote to approve the minutes, approve the financial statements for July 2018 and to pay the bills.

**Junior Council**

Alex Gasdaska resigned his position as Junior Council effective August 12, 2018. Alex graduated from Susquenita High School June 2018 and will be attending the University of Minnesota this fall.

A motion made by Dave Magee, seconded by Lance Barthel and approved unanimously to accept Alex Gasdaska resignation as the borough’s Junior Council person.

**Public Comment**

Stephanie Stoner of 207 Kings Highway is here for citizen capacity and has concerns with the garbage/recycling. The recyclables were still setting at the end of her driveway on Monday night when she returned from work. She feels the borough should keep curb side recycling and thinks a different day should be chosen for trash/recycling pick-up.

Allen Metzger of 398 Kings Highway, Lot 1 suggested the borough put up no parking signs along the north side of Park Drive. He has been seeing a white car parked there for three hours at a time.

Scott said there will be signs put up on the north side of Park Drive.

Roger Barrick of 319 Whitetail Terrace has concerns on Park Drive. There was three curbs needing to be done, he said there was one done. He noticed two pot holes that were tacked covered over it. He said it should have been cut out.

Scott said they would look at this on Tuesday morning prior to paving.

John Edkin of 337 Valley Street said there are no ADA curbs put in. John said this is a requirement. There are no ADA curbs on Kittochtinny Drive.

Greg said ADA ramps are not a requirement.

Rick Brewbaker of 246 Whitetail Terrace said Laurel Street has two seams going up. This is not a good thing. The pavement will eventually give out around the seams.

Steven Dowell of 702 Maple Avenue introduced himself and is very much honored to meet all of council. Steven has ten years of service with New Bloomfield and works at the House of Representatives office.

A motion made by Dave Magee, seconded by Alexandria Snyder and approved unanimously to put out to bid for paving with alternate for the remaining streets from the sewer project.
