### **Important Information**

#### § 13-301. Definitions.

PEDDLER - any person who shall engage in peddling as hereinafter defined.

PEDDLING - engaging in selling, peddling, soliciting or taking of orders, either by sampling or otherwise, for any goods, wares or merchandise, including subscriptions for magazines or other printed matter, the obtaining of contracts for home and building devices, repairs and improvements and the securing of contributions to various causes and organizations, from house to house, or door to door or from business to business or upon any street or sidewalk in the Borough or by a telephone within the Borough; provided, the word "peddler" shall not apply to religious proselytizing, anonymous political speech, distribution of handbills and the following: [Ord. 553]

- A. Farmers selling their own produce.
- B. Those selling goods, wares and merchandise, donated by the owners thereof, the proceeds whereof are to applied to any charitable or philanthropic purpose.
- C. To any manufacturer or producer in the sale of bread or bakery products, except that the term "milk or milk products" shall not include or apply to ice cream or other frozen desserts.
- D. To boys or girls under 18 years of age who take orders for and deliver newspapers, greeting cards, candy and the like or who represent the Boy Scouts or Girl Scouts or similar organizations and take orders for and deliver cookies and the like.
- E. To any person who works for an organization which has registered with the Pennsylvania Department of State, as required by 10 P.S.§162.1, et seq., known as the Solicitation of Funds for Charitable Purposes Act.

# § 13-302. License Required to Engage in Peddling.

No person shall engage in peddling in the Borough of Marysville without first taking out a license as herein provided.

## § 13-303. Application for License; Fee; Issuance; Grounds for Refusal.

- 1. Every person desiring to engage in peddling in the Borough of Marysville shall submit a written application to the Mayor, accompanied by two photographs (2 1/2 inches by 3 inches) of himself or herself, taken within 6 months prior to the date of the application.
- 2. The application shall state such person's name, age, sex, home address, business address, name and address of employer, if any, what he or she desires to peddle, the make and type of vehicle, if any, he or she will use, its registration number and whether he or she has ever been convicted of a felony, misdemeanor or a crime of any kind involving fraud or intentional misrepresentation or moral turpitude. Such application shall further state the length of time for which he or she wishes to be licensed and the number of helpers he or she has. Provided, where a person makes application for himself or herself and one or more helpers, all applicable personal information specified above shall be required for each helper and each helper shall be required to pay the required license fee and take an individual license.
- 3. The Mayor shall issue to each applicant a license (to which one of the applicant's photograph shall be affixed) within 15 days from the date of filing of the application. The license shall be displayed prominently by the peddler during such time as he or she shall peddle goods or services in the Borough. The license shall not be issued unless a proper fee, as follows, which shall be for the use of the Borough, shall have been paid to the Mayor. Fees shall be \$10 for a license valid for 1 day or fraction thereof; \$25 for 1 week or fraction

thereof; \$50 for a license valid for 1 month or fraction thereof; \$250 for a license valid for 1 year or fraction thereof.

4. A license shall not be issued to any person who has been convicted of a felony, misdemeanor or a crime of any kind involving fraud, intentional misrepresentation or moral turpitude and such persons shall not be allowed to engage in peddling in the Borough.

# **Bookmark§ 13-304**. Peddlers Sell Only Products Mentioned in License.

No peddler shall engage in the selling or dealing with any product not mentioned upon such license. (Ord. 513B, 4/9/2002, §4; as amended by Ord. 515A, 4/9/2001, §4; and by Ord. 540A, 4/9/2001, §4)

### § 13-305. Prohibited Acts by Peddlers.

No peddler shall:

- A. Hawk or cry his wares from any of the streets or sidewalks of the Borough, nor shall he or she use any speaker or horn or any other device for announcing his presence.
- B. Park any vehicle upon any of the streets or alleys of the Borough in order to sort, rearrange or clean any of his goods, wares or merchandise.
  - C. Deposit any refuse upon any of such streets or alleys.
- D. Maintain or keep a street or curbstone market by parking any vehicle upon any street or alley in the Borough for longer than necessary in order to sell therefrom to persons residing in the immediate vicinity.
- E. Occupy any fixed location in the Borough or upon any of the streets, alleys or sidewalks of the Borough for the purpose of peddling, with or without a stand or counter.
- F. Peddle goods or services on Sundays or before 9 a.m. or after 7 p.m. on Mondays through Saturdays. (Ord. 513, 4/9/2001, §5; as amended by Ord. 515A, 4/9/2001, §5; and by Ord. 540A, 4/9/2001, §5)
