Conditional Use Hearing

A conditional use hearing was held for Dignitas Property Management.

Insurance Renewal

Motion to accept the insurance renewal from Keystone Insurance

After exiting executive session, the motion was approved with one nay vote to add the extra \$100,000.00 under the umbrella coverage.

Leigh Ann Urban requested the insurance proposal be provided to council a month prior to the meeting.

Council asked Zachary Border about decreasing the flood insurance value. Zachary said he will meet with Robert Gill from Keystone Insurance regarding the value.

Planning Commission: David Magee received a copy of the new zoning ordinance and complimented the planning commission on putting it together. Charles Wentzel said he would like everyone on council to read the ordinance.

Code Enforcement Officer's Report: Zachary Border said he ticketed residents for high grass and weeds.
