## Heritage Boat Ramp

Ronda Kennedy-Rowe indicated the boat ramp is washing out and something needs to be done.

Council referred this to have Ken Miller and Pennoni look at the Heritage Boat Ramp tomorrow.

We need to first find out what the sink hole is. This will need to be further investigated.

#### **Basketball Court**

Christian Gasdaska said the broken glass and the ramp don't work well as a basketball court. It is great for tricks. He feels if the basketball court is fixed more kids would tend to play basketball.

Lance Barthel indicated we have our own equipment and the maintenance guys can take care of digging the existing pavement out. We will have to take a look at the basketball court to see what we can do.

# New Tires for Skid Loader

A motion was made by Lance Barthel, seconded by Ronda Kennedy-Rowe and approved unanimously to purchase new tires for skid loader from Wingfoot.

Aaron Richards requested the old tires from the skid loader to use as a back stop. Council said Aaron could have the old tires from the skid loader.

#### Frank Boyer

Frank Boyer of 316 South State Road stated his sidewalks and curbing were damaged when the sewer separation project was being done. Patch work was done on the curbs, but work did not hold up. He is requesting sidewalks and curbs need repaired or replaced.

Council referred issue to Pennoni Associated, Boroughs Engineer. Was there an issue with the workmen ship of the sidewalk and curb or did milling machine hit the curb to cause damage?

## Advertising Borough Manager

A motion was made by Lance Barthel, seconded by Charles Wentzel and not approved by council to pull old advertisements for hiring a borough manager.

Motion amended to take the advertisement to the personnel committee to decide the criteria needing to go into the advertisement for Borough Manager.

## Police Garage

Council requested Aaron Richards and Ken Miller get together for planning for the police garage and to have quotes ready for the next council meeting.

## **Commission Reports on File**

- The Marysville Fire Company had 10 calls in May, 5 within the borough.
- The Marysville Fire Company had their first paint night. The paint night went well.
- Food auction went well.
- Chicken barbeque was a great success.
- The next chicken barbeque will be held July; however we will be cutting back on the chicken. He suggested being early to assure you get the chicken dinner.
- There will be another paint night toward the end of June.
- Picked up the new fire truck on the 16<sup>th</sup>, started pulling equipment off from the old truck. The fire company spent the entire weekend getting the new engine ready. Engine went into service Sunday night and went out Monday on its first call.

# **Committee Reports on File**

Rich Stees of the Marysville Park, Pool and Recreation Foundation gave a check for \$1,500.00 to help deter the cost of the electrical work done at the pool.

There is a mandatory main electric inspection every three years to be done at the pool. The cost to repair the electrical at the pool was \$4,300.00. Shawn Wirick did all ground wire, fence, ada lift chair at no cost to the borough. There was a chlorine leak at the end of the season last year

which destroyed all contents of the box. Shawn Wirick charged their cost for the materials and no labor fees were added. Rich wanted to thank Shawn Wirick for his generosity.

Roger Barrick is a great help to the pool.

The last day of school party was a great success. We had over 300 kids attend the party.

Replacements of poles were done at the pool due to be rotted.

Aaron Richards would like to replace the hand guns at the borough. He received a quote of \$1,700.00 for four guns. The old hand guns are at least 15 years old. Aaron asked if the police officers could purchase the guns. A motion was made by Lance Barthel, seconded by Ronda Kennedy-Rowe and approved unanimously to purchase the new hand guns and allow the officer to purchase the old hand guns at trade in value.

License Plate Reader (LPR) Grant was preapproved for \$12,400.00.
