Deb Black and Michael Van Noy

Deb Black and Michael Van Noy of 212 Kings Highway are concerned with public safety on this road. Patrons are traveling fast on this road. They have concerns for children standing along the road and waiting for the bus. Patrons are running the stop sign at Kings Highway / Caroline Drive.

Deb Black and Michael Van Noy spoke with the borough manager at that time regarding speed humps. Scott said the speed humps would be used as a launching ramp. Speed humps would slow down the traffic. There is deer crossing as well at our property and deer walk down the middle of Kings Highway.

Patrons are worried about taking their pets for walks along Kings Highway due to the fast traffic.

The borough is not allowed to use speed humps to slow traffic down. Council referred the issue to the streets committee.

Michael Van Noy suggested having police officers set there at least in the morning from 6 to 8 am and in the evening from 5 to 7 pm to slow the traffic down.
