Streets Committee Minuets  
June 1, 2020

The Streets Committee Meeting was called to order at 1:30 pm on Monday, June 1, 2020 at the Marysville Borough Office. Present were Council members Lance Barthel, Dave Magee and Brian Webster, absent was member Steve Copp Also present were, Borough Manager Zachary Border, Borough Engineer Greg Rogalski

**New Business**

1. **Auction for the 1997 and 2009 Truck**

With the purchase of the new truck two of the vehicles currently owned can be sold. Zach brought up an auction such as CapCOG but it was decided that would not be worth the time. It was suggested if we have more things to sell then the two trucks Dave would be willing to host the auction as he has an auctioneer license. If not, we would post on line or do a sealed bid.

2. **Curbing on Cassell Street**

Since there was a lot of work done on the road by different utilities there really is no way to determine who caused the damage. The committee suggested to power wash the black marks off the curb.

**Old Business**

1. **Road Project – Jay Fulkroad and Sons**

There was no response from the company to fix the road. The Committee decided to have the solicitor send a letter letting them know that we will not be paying the rest of the money that was owned and will fix the project on our own.

2. **Suez - Paving of streets (Linden Ave)**

This will be started by the end of June.

3. **Bridge Inspection South Main over Fishing Creek**

The engineering team did do an inspection of the bridge and found that the supports of the bridge are still in good shape but will need some minor repairs which will help bring down the cost of the project and allow the focus to be on the super structure. Greg will send Zach a list of things that need to be done for the application to obtain the HATS grant money.

4. **Pole Building**  
This will be moved to long term planning.
5. **Liquid Fuels Account Update**  
Greg has all of the information he needs; the next step is to set up a meeting with PennDOT to make sure the borough is able to spend the money.
6. **Land Survey Behind the Borough Building**  
Zach reported that the survey work started on Thursday May 28 and once all of the field work was done, he would receive a report to share with council.
7. **Four Hour Parking Limit Sign**  
It was decided to recommend removing the four-hour time limit from the ordinance and to just allow public parking.
8. **Agility Program**  
Zach reported PennDOT is not interested in exchanging services with the borough for street sweeping 850. Zach will check with Ken to make sure if we do sweep it will not damage the sweeper.
9. **Truck**  
Committee decided to go forward and purchase the truck. It was then moved to finance to decide what funds to take the money out of.
10. **Speeding on Ridgeview Drive**  
The Committee decided against parking on both side of the street and wanted to have the item removed from the agenda.

Sally McCoy of 216 Park Drive was upset about the letter she received from the solicitor about the complaint she had made about the fence her neighbor had built at 218 Park Drive. She felt that the solicitor had placed the blame on her for the tree growing and causing sight issues. She felt the real problem was the fence and not the tree. The committee decided to ask the borough manager to find the original permit fence to make sure it was a legal fence and it would be discussed at the council meeting.
