New Business

1. **Speeding on Ridgeview Drive**

There was discussion about the best way to try to slow people down. One suggestion was to make parking on both sides of the street from Lauren to Caroline. Another suggestion was to talk to the police and try obtain one of the speed signs to show people how fast they are going.

2. **Tractor Trailers on North Main street**

This was discussed and felt the problem was due to GPS and that there was not much the borough could do.

3. **Sign at Boat Ramp**

The maintenance department would investigate the signs and report back to the borough manager.

Old Business

1. **Road Project – Jay Fulkroad and Sons**

The engineer sent a letter on March 25 letting Jay Fulkroad and Sons know that they would have 30 days from May 1st to come back and complete the job. So far there has been no response from Jay Fulkroad and Sons.

2. **Suez - Paving of streets (Linden Ave & Maple Ave)**

Nothing new on this just waiting to hear from Suez as to when they will start paving.

3. **Bridge Inspection South Main over Fishing Creek**

The Borough Engineer and Borough Manager had a meeting with PennDOT and Tri County planning to discuss funding opportunities replace the bridge. There was also some discussion about trying to roll 2 other projects paving the lions club parking lot and improving the walking trail around the field into the application. The committee decided to try to connect the two projects but that the bridge should be the priority.

4. **Pole Building**

There was some discussion about doing drilling one hole in the ground around the borough building to see if the ground would be able hold the pole building. It was decided that it was more then just the ground. If the building was built it would also cause concern with stormwater runoff.

5. **Liquid Fuels Account Update**

6. **Contracted Services for Plowing Areas not Owned by the Borough**

The solicitor provided a release form that was to be signed by the private businesses that the borough plows. The manager will start that process of getting the forms signed

7. **Land Survey Behind the Borough Building**

A quote in the amount 4,500 dollars from Burget and Associates for a survey of the area around the borough building was presented to the committee. The Committee thought the price was a little high but Greg explained it did include 2 visits. The Committee recommended that this item be moved to the finance committee.

8. **Four Hour Parking Limit Sign**

There was discussion about how it was not possible to enforce the 4-hour limit and how if it was enforced it would then push people to park in the neighborhoods. It was suggested that the signs be put back up but that it not be enforced. No conclusion was reached so it referred to the workshop session.

9. **Agility Program**

No additional discussion because PennDOT is still closed

10. **Truck**

The borough manager reported that he had a conversation with the solicitor who determined that council could not cancel the truck but there was a possibility to suspend the payment during the declared emergency. The Committee decided to pursue that option and directed the manager to contact the solicitor to start the process.

11. **Safety Manual**

This was referred to council for approval.
